A motion was made by Mayor Kelly (Harvard) to approve request (1), which was seconded by Mr. Hennings (McHenry County). The motion passed unanimously. A second motion was made by Mayor Kelly (Harvard) to approve request (2), seconded by Mr. Hennings (McHenry County). The motion passed unanimously.

Pace Suburban Bus Council of Mayors Meeting 9/20/24

Ridership Update:

For the month of June, Pace's system carried approximately 1.8 million riders

This past July, Pace carried approximately 1.9 million riders throughout our entire system, representing a 23.2% increase from the same period last year. The total includes our fixed route, dial-a-ride, vanpool, and paratransit services. This makes July the 2nd highest ridership month over the last year.

Overall, our systemwide ridership is up 13.8% year to date from 2023 and our fixed-route ridership is up 19.9%.

In 11 of the last 12 months Pace ridership have exceeded 70,000 riders on an average week day, pre pandemic Pace carried 100,000 riders per week day. So this puts Pace's weekday ridership well over 70% of pracademic riders for nearly a full year. As I reported previously in some of those months we reached 80% of pracademic riders, specifically in May 2024

ADA Paratransit ridership continues to grow beyond 2019 levels. Our ADA ridership is no 105%.

Rideshare Access Program attracts riders

Since the Rideshare Access Program (RAP) launched this past spring, we've been running promotions in different ways, and we're seeing strong results. RAP is our newest transportation service for eligible paratransit riders, allowing passengers with disabilities to take discounted rideshare trips with Uber or UZURV throughout our six-county service region.

We've been promoting RAP online and on social media, and we recently completed another direct mail push advertising the service to users. Ridership continues to increase as a result. Through the first three months of RAP, the program provided approximately 46,500 trips.

But in May alone, RAP provided 30,628 total trips! These numbers are impressive. We look forward to continuing our promotional efforts and serving more RAP riders in the future.

Potential Riders must be certified for ADA Paratransit by the Regional Transpiration Authority (RTA) to be eligible for RAP. An Uber or UZURV account is required before enrolling in RAP. Enrollment in RAP is voluntary.

Please note: Individuals access to ADA Paratransit services does not change. For those who have already enrolled in Pace's Taxi Access Program (TAP), you may enroll in either RAP or TAP but not both.

Vetra Pre-Payment for Coordinated Services

Beginning Monday, June, 17, 2024, last week, riders on both Dial-a-Ride and Coordination Projects can pay for trips using Ventra at the time of booking.

Pace operated dial-a-rides and coordination project riders (MCRide, Ride Lake County, Ride In Kane, Ride DuPage and Will Ride) will have the option to using Ventra during the booking process. Non-ADA riders can register for TripCheck and enter their Ventra card number into their TripCheck account.

Once their Ventra card is linked to our faring system, riders will have the option during the booking process, to have fares deducted from their Ventra account. *Please note fare will be deducted from their Ventra card at booking, all funds must be available.

Please encourage your non-ADA riders to sign up for TripCheck if paying for their trip using Ventra at booking would be a good option for them.

Staff shared a training document that walks riders through how to link a ventra card to their Trip Check accounts. I brought copies for the board members today.

Trip Check Application Launch

Pace's Paratransit TripCheck now available as mobile app

Our paratransit riders can now view trip information, cancel trips, and receive travel alerts directly through a new mobile app.

The new TripCheck app provides riders with another avenue to access information for their trips. The app is available for download on Apple's App store for iPhone users and the Google Play store for Android users.

Regional Day Pass Pilot Program

Later this morning Pace's Board of Directors will consider an intergovernmental agreement regarding a proposed Regional Day Pass Pilot Program. If approved, this would create an integrated day pass that would allow unlimited rides on all three transit systems—CTA, Metra and Pace—for the calendar day of purchase. The pass pilot is expected to be launched this year on the Ventra App after the vendor completes development and testing.

The proposed agreement sets the pricing parameters for the day pass for unlimited rides on CTA and Pace and on selected fare zones for Metra on weekdays, ranging between \$10 and \$16.

There will be one systemwide price on the weekend days of \$10.

Riders will be able to purchase this pass using the Ventra App at a discounted price in comparison to purchasing two existing passes separately (the CTA/Pace 1-Day Pass and the Metra day pass).

The fare revenue difference would be funded by the RTA and distributed to CTA. Metra and Pace.

ReVision

ReVision is an opportunity to rethink Pace's entire network of services, building on the principles of accessibility, equity and productivity defined in the Driving Innovation strategic plan.

This project will review and reimagine where and how often Pace routes should run, and what types of transit service are appropriate in different areas of the Chicago region.

ReVision will combine comprehensive technical analysis with an ongoing regional conversation about the values and priorities that stakeholders, riders, and the general public want the Pace network to reflect.

September 2024 Update

RTA seeks feedback on proposed reforms to improve transit service and accountability for riders and taxpayers

The RTA is advocating for new funding to come with reforms that would establish a stronger RTA with more influence on service, fare policy, and capital project prioritization. These are areas featured in RTA's <u>Transit is the Answer</u> strategic plan and CMAP's <u>Plan of Action for Regional Transit</u>, where the RTA's regional perspective and budgetary role could add value for riders and taxpayers. The <u>Transit is the Answer Coalition</u> met in July to gather feedback on the following reforms from legislative staff, advocates, and other stakeholders, and the RTA continues to seek feedback from other partners as the next legislative session approaches.

Regional Service Standards

A potential reform is for RTA to define regional service standards for minimum levels of service for each mode of travel to ensure a basic level of access to transit for residents. This could include additional accountability, requiring operating agencies to testify quarterly to the RTA Board on how they are meeting these standards and answer questions from the regional board.

Regional Fare Policy

Establishing a regional fare policy could help ensure simple, easy to understand fares and fare programs, that support travel across the system. A regional fare policy can make paying for transit more seamless for everyone while improving affordability for those who need it most.

Regional Planning & Capital Project Prioritization

Empowering the RTA with regional planning and capital project prioritization would help advance a systemwide vision and coordination on projects to tackle climate change and deliver more connected communities. A strong regional agency setting the vision and taking the lead on key federal and state grant applications would ensure that we are maximizing the benefits transit brings to the region.

Regional transit budget process begins, vote to be held in December

Each year, the RTA reviews, adopts, and monitors the annual operating budgets of CTA, Metra, and Pace. The process begins in earnest in the fall, when the Service Boards present their initial budget proposals to their boards and the public. Following these presentations, the RTA will schedule a series of public hearings throughout the region to present the proposed 2025 regional operating budget and five-year capital program. The Service Boards will present their final budgets at the RTA's November 22 Board meeting once their public comment period has concluded, and a final vote will be taken by the RTA Board of Directors in December. Previous regional budgets, capital plans, and other financial documents can be found on the RTA website.

Illinois Senate hosts regional hearings on the value of transit

To highlight the value of transit and gather input on funding and reform ideas, Senate Transportation Committee Chair Senator Ram Villivalam scheduled a series of six subject matter hearings to be held over the summer to continue the conversation about the future of public transit in the Chicago region. The first four hearings featured testimony from leadership at the RTA and Service Boards. The remaining hearings are scheduled throughout the region and in Springfield and can be viewed live at www.ilga.gov.

RTA seeks user feedback on online data portal

The RTA is seeking feedback from users of <u>RTAMS</u>, the agency's mapping and statistics website, to better understand who uses it and how it can be improved in the future. <u>Take the survey</u> now through October 21 to weigh in; it will take about 5 minutes to complete.

The last time a survey was conducted on RTAMS was in 2016, when a visioning survey provided direction on a full redevelopment and relaunch of the website in 2020. As part of that redevelopment, new content was added, improved reporting of projects and studies was deployed, a more stable hosting environment was implemented, downloadable data sets were incorporated, Americans with Disabilities Act (ADA) compatibility was addressed, and search and filter options were improved.

Illinois Tollway Update

Capital Plan – Investing in the Future

The Illinois Tollway is continuing to advance its planning process seeking input to inform its next capital plan and to shape the framework for the agency's long-term capital priorities.

The Tollway has established a Stakeholder Advisory Team to assist with defining program goals and providing regional input for the next capital plan, as well as a Strategic Planning Committee, a Board-level committee overseeing the agency's strategic and capital planning process with a goal of delivering plans in 2025.

I-PASS Sticker Tags

This summer, the Tollway has begun to mail I-PASS Sticker Tags directly to customers when their current I-PASS transponders expire. I-PASS Sticker Tags are the new, more efficient and cost-effective transponder technology.

In addition, I-PASS Sticker Tags can still be picked up at Illinois Tollway Customer Service Centers ordered online via the Illinois Tollway website or at a Jewel-Osco or RoadRanger retail location.

Customers will not be required to switch to the I-PASS Sticker Tag as long as they have a working transponder.

There is no deposit fee for I-PASS Sticker Tags. For customers with current transponders, the \$10 transponder deposit will be transferred into their pre-paid toll accounts once a new I-PASS Sticker Tag is registered to the account.

The introduction of I-PASS Sticker Tags is being done in collaboration with other E-ZPass agencies and will ensure that customers have continuity in service wherever they travel in the 19 states that are part of the E-ZPass consortium.

I-PASS Assist

The Illinois Tollway's I-PASS Assist program continuing to provide more assistance than ever.

Income-eligible drivers are receiving the cost-saving benefits of I-PASS after signing up for I-PASS Assist Accounts that also offer few up-front costs. In addition, I-PASS Assist customers may be eligible to have invoice fees dismissed once enrolled.

We've put together a tool kit <u>I-PASS Assist Communications Toolkit - Illinois Tollway</u> if you'd like to promote this program to your residents.

To be eligible for enrollment in I-PASS Assist, household income must not exceed 250% of Federal Poverty Guidelines as verified by the Illinois Department of Revenue or qualified by the Illinois Department of Human Services for cash and food assistance programs.

2024 Northeastern Illinois Priority Transportation Investments

CMAP recently released <u>Northeastern Illinois Priority Investments</u>, a blueprint documenting the highest-priority projects across the region for 2024. It reflects collaboration between CMAP and our partners at the Illinois Department of Transportation, the Chicago Department of Transportation, the Regional Transportation Authority (RTA), the Chicago Transit Authority (CTA), Metra, Pace, the region's seven

counties, and the CREATE Program partners. Additional <u>online resources</u> to provide communities and partners with the essential information they need to know about Infrastructure Investment and Jobs Act and its benefits to the region are also available.

Plan of Action for Regional Transit (PART)

Following CMAP's delivery of the <u>PART report</u> to the General Assembly and Governor's Office, legislative deliberations about the future of transit funding have continued. Most recently, the Climate and Equitable Transportation Act (CETA) was filed, which includes three bills that address several transit and climate issues in the region. One component of CETA, the Metropolitan Mobility Authority Act, details several reforms to transit governance and operations in northeastern Illinois. A companion appropriations bill was also introduced with the intent to provide \$1.5 billion in additional operating funds each year to transit across the region.

PART outlined three areas that must work in tandem to address the \$730 million fiscal cliff facing our region in 2026 and strength our transit system: system improvements, funding solutions, and governance reforms. CMAP will continue to provide feedback and input in alignment with the PART report. We look forward continued collaboration with partners, stakeholders, and legislators to strengthen transit in the region.

Climate Action Planning

CMAP collaborated with the Metropolitan Mayors Caucus to prepare the <u>Priority Climate Action Plan</u> that will set the region on a path to reduce greenhouse gas emissions and allow communities in northeastern Illinois to compete for investments from the U.S. EPA's Climate Pollution Reduction Grant Program. The plan supports equitable investment in policies, practices, and technologies that can enhance the quality of life in our region. The goal is to reduce pollutant emissions, create high-quality jobs, and spur economic growth.

CMAP has begun work on the regional Climate Action Plan. Due in June 2025, the plan will provide an overview of major regional sources and sinks of emissions, develop emissions scenarios and targets, and recommend strategies to reduce emissions.

It also outlines safety strategies based on the safe system approach with a profound consideration for equity principles. It is IDOT's intention for this document to be an important tool for stakeholders to continue to address the needs of VRU's in their communities.

To assist in the use of the VRUSA for the planning of future projects that address the safety of VRUs, a <u>VRUSA Dashboard</u> has been created that allows the user to view the results of the VRUSA data analysis in a way that can be filtered to specific areas of the state.

Each candidate project must be a deficient bridge eligible for the Local Bridge Formula Program (formerly Surface Transportation Program-Bridge). The total project cost for all engineering, utilities, land acquisition, and construction costs, including minimal approach work, must total a minimum of \$1,000,000 for local special bridge candidates. Any proposed local bridge must be under the jurisdictional responsibility of a county, municipality, or township and located on a route with appropriate jurisdictional responsibility.

Please work with your District Local Roads Engineer to complete the required special bridge fund request form along with a briefing paper. The PRO 2171 application form is available on the IDOT website. Each candidate project must also complete the LRS Grant Application, LRS Risk Assessment (BLR 04101), and a Conflict of Interest Form (BoBS 2831). Applications are required to be submitted electronically through the application's email feature to your appropriate District Local Roads office. The Districts must receive all program applications by October 9th, 2024.

CMAP FFY26-2030 Call for Projects: STP-Shared Fund, CMAQ, CRP, and TAP-L

Dear Mr. Duffin:

In 2020, the Village applied for Federal STP funding for the Riverside Drive Improvements between Johnsburg Road and the south Village limits. The project received \$1.5 million in STP funding for construction and construction engineering, which is the maximum allocation under current auidelines.

Bids were opened in September of 2023 but greatly exceeded estimates and were rejected. Plans for the project were updated, elements removed, and the project was re-bid in January 2024. Again, the bids exceeded estimates, but due to deteriorating conditions of the Dutch Creek culvert as well as the roadway pavement, the Village determined it had no choice but to accept the bid and proceed with the project. The as-bid total for the project is \$2,849,871.00, of which the Village's share is \$1,349,871 (or 47%).

The Village of Johnsburg is requesting that the Council of Mayors program an additional \$779,897.00 towards the construction of the Riverside Drive Improvements. A funding summary is hereby attached as Exhibit A. The project is currently under construction and is targeting substantial completion in Fall 2024.

The McHenry County Council of Mayors Bylaws describes the organization, relationships, and procedures by which the Council operates. This document has received several, somewhat periodic updates since the first version of the bylaws were approved by the Council in 1992. However, the

bylaws have not been modified since 2016.

After reviewing the document, staff believes that the bylaws would benefit from a few minor changes. To be clear, no substantive changes are proposed to the body of the text. Instead, the

proposed revisions will reflect how the Council has operated for the past few years.

Two changes to the bylaws are proposed by staff. First, is the renaming of the positions of

"Chairman" and "Vice Chairman" to "Chair" and "Vice Chair." In the attached Proposed Revisions,

these changes make up the bulk of the edits to the bylaws.

The second change would modify the section of the bylaws concerned with meeting procedures.

Currently, the bylaws state that meetings will be held on Thursdays at 2:00 PM, something which has not taken place in several years. The specific reference to Thursdays at 2:00 PM would be

removed from the bylaws. Optionally, the Council may vote to either approve new language to

reflect our regular Friday morning meetings or leave any reference to a specific date and time out of

the bylaws altogether.

Amendments to our bylaws are adopted upon the affirmative vote of a two-thirds supermajority of

members present.

ARTICLE I - NAME, PURPOSE

The name of this organization is the McHenry County Council of Mayors (hereinafter "Council").

The purpose of the Council is to program Surface Transportation Program (hereinafter "STP") federal funding and to review and evaluate transportation issues affecting McHenry County and McHenry County area municipalities.

ARTICLE II - MEMBERSHIP

The Council shall be composed of McHenry County and municipalities with residents within McHenry County. Additionally, one or more adjacent counties who elect to participate in the Council and have indicated their choice to the Chicago Metropolitan Agency for Planning (hereinafter "CMAP"). CMAP is the Metropolitan Planning Organization (hereinafter "MPO") for northeastern Illinois.

The members of the Council are pursuant to the attached Appendix A - Council Member List.

McHenry County's/County(s) representative shall be the County Engineer or his/her designated representative. A municipal representative shall be an elected mayor/president or his/her appointed municipal representative. All representatives must be county/municipal officials or employees. Each member is allowed one (1) voting member and two (2) alternate voting members.

ARTICLE III - STAFF

The primary staff for the Council is the Planning Liaison (hereinafter "PL"). The PL will handle all Council business and coordination with CMAP and the Illinois Department of Transportation (hereinafter "IDOT"). The McHenry County Division of Transportation will employ and administer the PL.

ARTICLE IV - OFFICERS

The officers of the Council are a Chairman, a Vice-Chairman, and a Secretary. The Chairman and Vice-Chairman shall be elected at the regularly scheduled May Council meeting in odd numbered years. In the event that the Council does not meet in May, the Chairman and Vice-Chairman shall be elected at the next regularly scheduled Council meeting. The Chairman and Vice-Chairman must be a municipal mayor or president. Officers may serve consecutive terms.

ARTICLE V - DUTIES OF OFFICERS

Chair The Chair shall preside at all Council meetings and shall appoint subcommittees as necessary.

Vice-Chairman: In the absence of the Chairman, the Vice-Chairman shall assume the duties of the Chairman. In the event of the resignation of the Chairman, the Vice-Chairman shall fill the unexpired term of the Chairman and a new Vice-Chairman shall be elected to fill the unexpired term of the Vice-Chairman.

Secretary: The PL shall serve as secretary and shall compile Council meeting agendas and prepare and distribute Council meeting notices and Council meeting minutes.

ARTICLE VI - AGENDAS

Any member of the Council or applicable government agency may submit items to be heard and discussed by the Council as part of the published Council meeting agenda. All meeting agenda items must be submitted to the secretary a minimum of fifteen (15) days prior to the regularly scheduled Council meeting.

ARTICLE VII - MEETINGS

The Council shall meet a minimum of four (4) times per State fiscal year (July 1 through June 30). Meetings will generally be held on a Thursday at 2:00 p.m. at various locations in McHenry County. The meeting dates, times, and locations will be determined for the following year at the last meeting of the year. Generally, meetings will be held at 9:00 AM on the third Fridays of January, March, May, July, September, and November.

Meeting Notice: Written or electronic meeting notices must be delivered to members a minimum of seven (7) calendar days prior to a Council meeting. Meeting agendas and supporting materials shall be delivered to members a minimum of three (3) business days prior to a Council meeting.

Meeting Cancellation: A regularly scheduled Council meeting may be canceled at the discretion of the Chairman if no items of business need to be discussed.

Special Meetings: Special Council meetings may be called as needed by the Chairman. Notice of any special Council meeting shall be delivered to members a minimum of three (3) business days prior to a special Council meeting.

ARTICLE VIII - VOTING

Seven (7) members shall constitute a quorum. A Council meeting must have a quorum to conduct business and vote on motions or requests/propositions.

Each member shall have one (1) vote. Members must be present at a Council meeting to have their vote counted and recorded.

All motions or requests/propositions before the Council shall be decided by a simple majority of the members present.

ARTICLE IX - AMENDMENTS

Proposed amendments to the bylaws of the Council shall be delivered to all members a minimum of seven (7) calendar days before a Council meeting and may be adopted at any Council meeting upon the affirmative two thirds (2/3) super majority vote of the members present.
